**Judges** are ignoring reports by professionals that state the father is mentally and emotionally abusing their children and giving these fathers custody. Mothers are being blamed for their children's anger or being said to have psychological disorders without proof of such disorders. The courts dysfunction adds to the mother's burden of keeping her children safe.



## Child Protective

**Services (CPS)** is allowing the system to be bogged down by abusive fathers making false reports. There is no reprimand for this misuse of the organization and the harassing of the mothers. CPS does not put in their reports when they make a mistake in reporting, and this allows these mothers to look as if they are not protecting their children. CPS recommends to the courts that a



psychological evaluation be done on the mothers. What is interesting is that the psychologist does not understand domestic violence, PAS, or how the abusers works and then mothers are misdiagnoses and the pattern continues. Because of these inaccurate reports, children continue to be mentally, verbally, and physically abused by their fathers and the court system.

## Guardian Ad Litem

**(GAL)** are lawyers represent children without proper training in domestic violence, PAS, and affects of abuse on the children. GALs are blaming mothers for following procedures of the court system and filing CPS complaints to protect their children.

*The GAL, Donna Mobilia, in court stated that a mother was running around "reeking havoc" because she was filing complaints and violation.*

*The system is abusing authority and has a lack of accountability.*

We need to refuse to tolerate lying judges, attorneys, politicians and their cover-ups and deceptions.

Our judges need to be monitored for abuse of the laws.

Bad lawyers, of any kind, need to be put out of business.
